- RELEASE OF LIABILITY AND VARIOUS RIGHTS:** In connection with My Household's voluntary involvement/participation in activities undertaken for, and with the participation and support of MORIAH Cooperative Inc. I hereby attest that attendance, participation and/or involvement in such Activities is voluntary, that My Household is participating at our own risk, and that I have read the foregoing terms and conditions of this release. Furthermore, My Household grants permission and conveys to MORIAH, including but not limited to any royalties, proceeds or other benefits, all rights, title and interest in photographs, video recordings, audio recordings and quotations from My Household during our involvement with MORIAH Activities.
- My Household may elect to discontinue participating in MORIAH Activities and/or performing our volunteer services at any time. My Household agrees to comply with all MORIAH policies, procedures, trainings, or staff directions as relates to MORIAH Activities. I also understand that MORIAH is not responsible or obligated to provide any financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.
- CONFIDENTIAL INFORMATION:** My Household, in the course of participating in MORIAH Activities and/or performing volunteer services and responsibilities may acquire or be exposed to information that is proprietary or confidential to MORIAH, including, without limitation, past, present and future trade secrets, donor information, volunteer information, financial information, procedures, methods, technical data, techniques, and computer software code and information pertaining thereto, copyrights and copyright applications, research and development, financial, legal and marketing data and other technical, business and financial information, whether written or oral (hereinafter referred to as "Confidential Information"). My Household agrees to protect and safeguard such Confidential Information and not to reveal, divulge or make known this information to any other person without express written consent of MORIAH.
- My Household has reviewed the informational materials related to the Activities and is prepared to follow the participatory instructions contained therein.
- I understand and agree that by providing MORIAH with my contact information MORIAH may notify me and my Household of upcoming events, activities fundraising efforts and opportunities to support MORIAH. - CHOICE OF LAW:** This Agreement shall be governed by laws of Arizona. In the event that any clause or provision of this agreement shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this agreement, which shall continue to be enforceable.
